2004 U.S. SENATE ELECTIONS HAVE HIGH STAKES FOR AMERICA'S MIDDLE CLASS

DRUM MAJOR INSTITUTE REPORT SHOWS WHICH CANDIDATES FOR RE-ELECTION VOTED WITH THE MIDDLE CLASS IN 2003

New York City, September 1, 2004 — In 2004, voters in 34 states will choose a U.S. Senator to represent their interests in Washington D.C. Of those 34 races, 16 will feature incumbent U.S. Senators with a history of supporting polices to strengthen and expand the middle class, and ten will feature incumbent U.S. Senators with a history of voting against the interests of the middle class in 2003, according to a report from the non-partisan Drum Major Institute for Public Policy (DMI).

This special report is based on the findings of DMI'S "Middle Class 2003: How Congress Voted," the first-ever, first-annual scorecard of votes on legislation that significantly impacts America's middle class. Representatives were graded on their votes on key legislation that helps the middle class (such as the American Dream Downpayment Act, the Pharmaceutical Market Access Act) and hurts it (such as Bankruptcy Abuse Prevention and Consumer Protection Act and the Death Tax Repeal Act). In it we spotlight the 2003 voting records of the 26 incumbent U.S. Senators seeking re-election in 2004 on issues important to the middle class.

Based on their votes, Senators Evan Bayh (D-IN), Barbara Boxer (D-CA, Tom Daschle (D-SD), Christopher Dodd (D-CT), Byron Dorgan (D-ND), Russ Feingold (D-WI), Daniel Inouye (D-HI), Patrick Leahy (D-VT), Blanche Lincoln (D-AR), Barbara Mikulski (D-MD), Lisa Murkowski (R-AK), Patty Murray (D-WA), Harry Reid (D-NV), Charles Schumer (D-NY), Arlen Specter (R-PA), and Ron Wyden (D-OR) earned a grade of B or better for their support of the middle class in 2003.

Senators Robert Bennett (R-UT), Sam Brownback (R-KS), Jim Bunning (R-KY), Christopher S. Bond (R-MO), Mike Crapo (R-ID), Charles Grassley (R-IA), Judd Gregg (R-NH), John McCain (R-AZ), Richard Shelby (R-AL), George Voinovich (R-OH) earned a grade of C or worse for their support of the middle class in 2003.

"We hope that this scorecard will serve as a yardstick for middle-class Americans to measure how effectively Congress is acting in their interest," said DMI President Fernando Ferrer. "We believe that better policy will be created, and Americans will live better lives, when middle-class Americans know how their legislators vote on the issues that matter the most to them—and, just as important, when legislators know that their middle-class constituents are watching."
